Immigration & Asylum Fee Scales for Self-funding clients

This fee scale summarises our charging fees for immigration and asylum advice and services. At an initial meeting, potential clients will be advised of whether they can seek legal aid. Check for legal help under the Legal Aid scheme - <https://www.gov.uk/legal-aid/eligibility/>

A summary of fixed-fee services for self-funding clients is set out below for a range of cases. If a case is complex, self-funding clients will be advised of this at the initial consultation, an estimate will be given of costs and work will be carried out at an hourly rate. It is important to note that in addition to these charges there may well be disbursement costs payable (for example, Home Office and court fees, or payments to experts or doctors for reports etc.) over which we have very limited or no control, and which will probably have to be paid at the full rate. We will notify prospective clients in advance of any such disbursements. Payment will need to be made at the end of each stage of the case.

We will offer a 10% discount on charges (but not disbursements) for repeat clients.

Please note that our organisation is not VAT registered. Therefore VAT @ 20% will not be added to the fees outlined below. Payment is currently only accepted in cash, cleared cheque funds, and bank transactions.

<u>Free 20 minutes diagnostic assessment</u>			This will be a telephone discussion to understand the service needed by a potential client.
Initial 1 hour assessment and advice	£100.00	£90.00	Interview with an immigration lawyer to take verbal instructions with advice to you on the appropriate course of action. This will be confirmed in a written advice letter which you will receive at the time or shortly afterwards.
Review of complex immigration history taking over an hour	£75 per hour	£65 per hour	Where the application is complex or there is a long immigration history it will not be possible to give good advice in an hour. Your immigration lawyer will review all your documentation and papers and take verbal instructions from you. It may well be advisable to make an application to the Home Office for them to disclose the file that they hold on you (a "Subject Access Request" or SAR). You will be given verbal advice, which will be followed shortly afterwards in writing. We can make a SAR application for £60.00.
Complex immigration and asylum matters not suitable for fixed fees	£75 per hour	£65 per hour	We will provide a written estimate of the range of hours your matter is likely to take together with a case plan and a list of anticipated disbursements. You will be updated regularly on costs during the course of the work.
